Continuum of Care Program

Purpose & Description

Continuum of Care (CoC) Program

- Authorized by
 - Subtitle C of title IV of the McKinney-Vento Homeless Assistance Act
 - CoC Program Rule 24 CFR part 578

CoC Program Description

- Promote a community-wide commitment to the goal of ending homelessness

CoC Program Description

- Provide funding for efforts:
 - Quickly rehouse those homeless while minimizing the trauma and dislocation caused by homelessness
 - Promote access to and effective utilization of mainstream programs by those homeless
 - Optimize self-sufficiency among those experiencing homelessness

CoC Program Description

■ Housing Types:

- Permanent Housing
 - Rapid Re-Housing
 - Permanent Supportive Housing
- Joint Transitional Housing & Permanent Housing (Rapid Re-Housing)

FY 2022 CoC NOFO HUD Priorities

- Ending Homelessness for All Persons
- Using a Housing First Approach
- Reducing Unsheltered Homelessness
- Improving System Performance
- Partnering with Housing, Health, & Service Agencies
- Advance racial equity and address racial disparities
- Improving assistance with LGBTQ+ individuals
- Support local engagement to increase supply of affordable housing
- Engage persons with lived experience of homelessness

CoC Program Description

- **Local Competition:** NWA CoC process to select projects to be included in the collaborative application and submitted for the FY 2022 NOFO Competition
- **Collaborative Application**- NWA CoC is designated Continuum of Care for region- Washington, Benton, Carroll, & Madison Counties. Submits Application for region
- **AR-501 Fayetteville/Northwest Arkansas CoC**

Collaborative Applicant

NWA CoC Submits Application for Funding for All Projects for Local CoC

Projects

Project Proposals Submitted to the CoC by Member Organizations for Consideration to be included in the Collaborative Application

Rank & Review Committee

- Develops Rank and Review Criteria
- Submits Priority Listing of Projects to CoC Board of Directors

NWA CoC Board of Directors

- Approves R & R Criteria
- Approves R & R Priority Listing of Projects to be Included in Application

Application Process

Project Proposals

- NWA CoC Announcement of Local Competition
- Defines Priorities in Alignment with NOFO
- Accepts Project Proposals from Local Organizations
- NWA CoC Rank & Review (R & R) Committee Evaluates & Selects Projects to be Ranked
- Organizations Notified of Selection/Non-Selection

Project Selection

- R & R Committee Review and Ranks Projects
- Submits Priority Listing of Projects for Inclusion in the Consolidated Application to NWA CoC Board of Directors for Approval
- Board Approves Priority Listing
- Organizations Notified of Selection/Non-Selection

Submission

- Organization Projects Submitted in HUD's e-snaps system.
- CoC Uploads Organization Projects According to Priority Listing in the the CoC's Consolidated Application and Submits the Application on behalf of the CoC.

Important Deadlines

- Collaborative Application Submission Deadline-
 - September 28, 2022
- Local Competition Details and Deadlines
 - Letter of intent – New & Renewal Projects – August 24, 2022
 - Full application – September 2, 2022
 - Rank & Renewal Report – September 9, 2022
